

The following agreement is between the [Department of the Environment, Food and rural Affairs](#) (the Authority), the Climate Impacts LINK Project ([Climatic Research Unit, University of East Anglia](#)) (the Agent) under DEFRA contract EPG 1/1/154 and the (the Licensee) in respect of data/software supplied by the Agent.

1. Subject to the terms and conditions herein, the Authority grants to the Licensee a non-exclusive Licence to use the data/software detailed below:

2. Such Licence does not permit the use of the data/software for commercial exploitation, business use, resale or transfer to any third party without the written consent of the Agent. Any unauthorised use will result in the immediate revocation of the Licence under condition 10 below. Within 14 days after the termination or discontinuance of this Licence for whatever reason, the Licensee shall return or destroy (as the Agent shall instruct) the data/software and copies, in whole or in part, in any form including partial copies of modifications of the data/software received from the Agent or made in connection with this Licence, and all documentation relating thereto and to furnish the Authority with a certificate, certifying that the same has been done, unless the Licensee has obtained the Agent's prior written authorisation to retain one copy for archive purposes only.

3. The Agent shall provide one copy of the data/software and associated documentation where appropriate within 30 days of the Licensee signing this agreement. The Licensee is to pay the following handling charges to the Agent within 30 days of receipt of the data/software:

5. No liability is accepted by the Authority for any errors or omissions in the data, software or associated information and/or documentation.

6. Licensed use of the data/software shall include acknowledgement of Crown Copyright where appropriate.

7. The Authority retains the intellectual property rights on the data/software.

8. The Authority requires the following acknowledgement in any publication of scientific reports and papers arising out of use of the data/software and/or information supplied by the Authority:
