## NCEO Theme 5 - Cryosphere and Polar Oceans - CONDITIONS OF USE

During the embargo period (a maximum of two years from the end of data collection/production) access is restricted to NCEO Theme 5 Scientists and those authorised by the Data Creator/delegated Authoriser who have agreed to the foll owing Conditions of Use and the General Conditions of Use:
